Please check your **Passports – Docs – Forms – Photos – Copies – and – Payments**

- 01 Yes my Passport have (2) blank visa pages side by side and it will remain valid for more than (6) months from the date of my arrival in Brazil.
- 02 Yes I sent my Original and Signed Passport together with my Paper Work
- 03 *Yes visa for minor we sent a notarized Copy of the minor Birth Certificate and Father & Mother signed and Notarize paper work needed *
- 04 Yes I sent my (1) Visa Request Form Signed 05 Yes I sent my (1) Copy of my Drivers License
- 06 Yes I sent (1) Passport Photo (2" x 2") or I sent \$10.00 to print two by email
- 07 Yes I sent (1) Copy of my Itinerary or I sent \$10.00 to make one and yes I will arrive in Brazil in less than 90 days from today's date
- 08 *** No I am not American and I sent a Notarized Copy of my Green Card and/or any Other Doc to prove My Legal Status in this country ***
- 09 Yes I sent a Liability Business Letter Head Signed & Notarized for my Bus. Visa and I did check the Bus. Letter Sample and Notes

-- **YELLOW FEVER SITUATION**

- 10 No I didn't go to these Countries in the Last (90) Days and I don't need to send my Yellow Fever Vaccination Card
- 11 Yes I did go to these Countries in the Last (90) Days and I sent (1) copy of my Yellow Fever Vaccination Card

-- **VISA TYPE and CONSULATE/EMBASSY FEES**

- 12 Yes I did send \$ 160.00 For My Tourist Business Visa Fee
